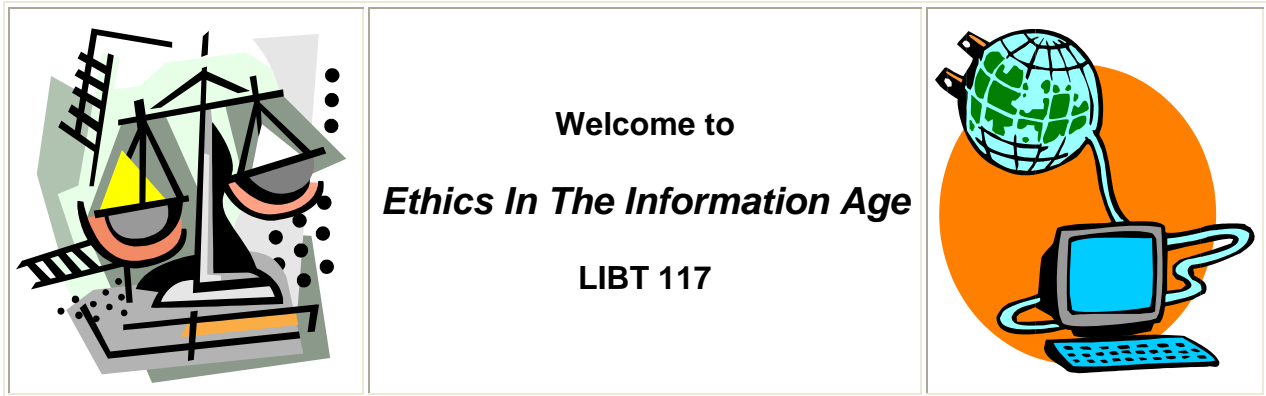

Dear Student,

Welcome to Library/Information Technology Online at Cuesta College! I will be your instructor in the upcoming online version of *Ethics in the Information Age*. This letter is to inform you of some important details prior to the beginning of the Fall 2009 online class. Please read these pages carefully!

In the past students in this course have included Library Technology students, Web Development Technologies students, students interested in the subject and students who desperately needed one more unit. The class tends to fill quickly. If you get a slot on the paid wait list, you will be included in the course.

Class Requirements

As you already know, you need to have an e-mail account and access to the World Wide Web. The required textbook for the course will be:

Some material will also be required from:

If you are taking other courses in the Library/Information Technology curriculum here at Cuesta, you probably will be purchasing this book. It also will be available for 2 hour, in library use only at both the SLO and NCC Libraries.

The content of this course is constantly changing. As the frontiers of the World Wild Web shift through cyberspace new topics emerge to serve as the basis for discussing the age-old conflicts between:

- ✓ The right to know;
- ✓ The right to privacy;
- ✓ The right to own and profit from intellectual property; and
- ✓ The right to protect our children and our nation.

In order to include late developing issues, the final syllabus for the course will be distributed to you in early October.

Computer Requirements

The following equipment and software are required for this class:

- A working e-mail account;
- Access to the World Wide Web—a broadband connection (DSL or cable) is strongly recommended;
- Web Browser: click either [Mozilla Firefox](#) OR [Microsoft Internet Explorer](#) for a free download if you are unsure if you have a recent version;
- Adobe Reader plug in. This is a free plug in that enables you to display the course readings. If you do not already have this plug in, you can download it at: [Adobe Reader](#).
- Word processing software capable of saving files in rich text format (.rtf files). *Word* or *WordPerfect* are among the programs that meet this criteria; and
- Basic computer experience.

Mandatory Meeting

There is **no** mandatory class meeting for this course. It is a **late start course beginning on October 19rd**. However an orientation assignment and a short writing assignment will be due on October 23rd and must be completed before you are allowed to view the first lesson. The course will be delivered using *Blackboard*. A few days before the beginning of the course enrolled students will be e-mailed a URL, an ID and a password needed to gain access to the course site. A short writing assignment will be due on October 23rd and must be completed before you are allowed to view the first lesson. **If these assignments are not completed on time, you will be subject to be dropped from the course so that any students on the wait list can be accommodated.**

Course Requirements

Grades will be based on the following:

- One short introductory essay;
- Several weekly quizzes;
- Contributions to weekly online discussions;
- A major group project; and
- A final exam.

Although this is a one unit course, due to its compressed nature you can plan on spending a **minimum** of six hours a week on course work. You cannot be successful in the course unless you log into the course site approximately every other day—particularly during the first few weeks when your project team is getting organized. The team project can be a great experience or your worst nightmare. If all team members do their fair share, it can be an

enjoyable activity. Therefore it is important for **every** team member to communicate regularly and effectively with others in the group.

Final Examination

The final exam will be composed of questions from the weekly quizzes and essay questions based on the topics covered by the group projects. Each group is responsible for helping the class prepare for the final exam by thoroughly and concisely presenting one topic of major concern. The group projects will be posted in time for all to use them in preparing for the exam.

Those of you who live within 50 miles of the campus will be expected to take your final exam on campus **December 14th from 6:00 to 8:00 PM. For those of you out of the San Luis Obispo County area, you must find a monitor**, acceptable to me, who will agree to administer your exam. It will be taken online so computer with a reliable Internet connection needs to be available. Many librarians and other educators may be willing to help you.

Monitoring Your Cuesta Email:

You are responsible for checking your Cuesta email account periodically after you enroll and before the class begins. You will be given choices if you respond quickly—on a first come, first served basis. This will be the way I will give you instructions on how to get into the class site. After the class officially begins, we will use the email function within *Blackboard.com*. My e-mail address until the class begins is DDowell@cuesta.edu. Put **LIBT 117** in the subject block and the email will receive priority attention.

Helpful Hints

If you have not taken an online class before, you should consider enrolling in *DIST 101*. It is a 0.5 unit class in which students can explore whether online learning is for them. It also allows students to develop some of the technology skills that will be useful in any online course. Sections of this course are being offered both in Summer and again during the first three weeks of Fall 2009. It is completely online.
