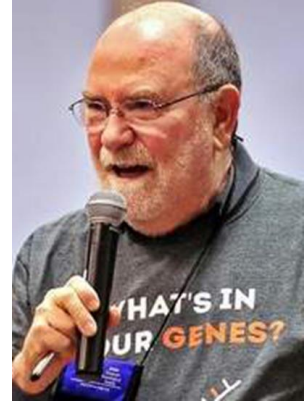

**Director of Libraries, Illinois Institute of Technology (1981-90)**. Organized a university library system to replace services previously provided on a contractual basis to support PhD programs in fifteen disciplines, graduate professional degrees in nine additional areas as well as the undergraduate curriculum. Renovated and expanded library space four fold. Introduced "pc" work stations and expanded automation of library operations. Mentored colleagues with hardware and software problems as an in-house "pc guru". Increased endowment more than six million dollars and doubled collections. Recruited and developed staff of twelve other librarians and twenty support staff. Developed collection in selected areas. Served on Reference Desk during staff shortages. Reported to the Provost and sat on Academic Council of Deans. Member of Graduate Studies Committee (1981-83), Undergraduate Curriculum Committee (1981-83), Academic Computer Center Advisory Committee (1982-84 and 1987-88) and IIT Integrated Information System Task Force (1987).

**Assistant University Librarian, Duke University (1975-81)**. Responsible for system-wide planning, budgeting, automation, facilities and other support services. Coordinated a budget of \$6,000,000 (1980 dollars). Responsible for the personnel program for 70 professionals, 140 support staff and 175 student assistants. Supervised 3 professionals and 12 supporting staff. Third in chain of authority for the library system. Duke automation representative to Triangle Universities Library Cooperation Committee (TULCC) and the Triangle Research Libraries Network (TRLN) Technical Advisory Committee (1979-80). Member of the TRLN Computer Hardware Review Task Force (1980-81). Member of the Long Range Planning Committee and chaired its Organization and Staffing Task Force (1977-78). Chaired the Support Staff Classification Committee (1977). Member of the Library Affirmative Action Committee (1975-77) and the Librarians' Benefits Committee (1975).

**Head, Administrative Services Department, Iowa State University Library (1972-75)**. Responsible for the personnel program for 110 support staff and 175 student assistants, the Bookkeeping, Supplies and Equipment Section, the Shipping and Receiving Section, and the Photoduplication Section. Supervised an accountant and 9 supporting staff. ARL Management Review and Analysis Program (MRAP) Study Team and chaired its Policies and Organization Task Forces (1972-73). Library Display Policy Committee (1972-73). Committee that developed a classification and pay plan for the classified staff members in the three state university libraries (1974). University Clerical Review Committee (1974) and the University Affirmative Action Committee (1974-75).

**Research Assistant, Library Research Center, University of Illinois (1971-72)**. Conducted a survey of reference services and needs of a 26 member public library system, constructed the Indexes of Public Library circulation and expenditures, and participated in the Illinois School Library Media Survey.
